Military and Veteran Students at Penn State



Helping to serve the education needs of our military has always been a part of Penn State's mission. We currently have more than 4,000 student veterans enrolled, and almost half of those students are studying online with the Penn State World Campus. This represents approximately **18%*** of the undergraduate student population.

In 2014, *U.S. News & World Report* recognized Penn State as the No. 1 national university for veterans.

Services Available for Penn State's Military and Veteran Students

Penn State in San Diego

Penn State will have its first dedicated teaching site on a military base in the fall of 2015, when select courses through Penn State World Campus will be offered at the Marine Corps Recruit Depot in San Diego. An on-base office is staffed with Penn State employees to provide direct assistance and information to these recruits.

Legal Clinic for Veterans and Servicemembers

The Penn State Law Veterans and Servicemembers Legal Clinic is designed to fill a critical gap that exists between the demand for specialized legal assistance and the limited supply of such services in Pennsylvania and across the nation. Initially, the clinic will focus its work in three areas: Veterans benefits appeals, veterans rights cases, and state and federal policy matters that pertain to veterans and service members.

Fry Scholarship Benefits

Effective summer 2015, the Fry Scholarship covers the full cost of a college education for all of the children and spouses of members of the United States Armed Forces who have died in the line of duty while on active duty on or after September 11, 2001. Covered costs include 36 months of tuition and fees up to the maximum in-state tuition, as well as a monthly living stipend and book allowance. All eligible veterans and dependents receiving Fry Scholarship benefits will be eligible for in-state tuition regardless of residency.

Priority Registration

Penn State's Faculty Senate approved priority registration for honorably discharged student veterans of the United States Armed Forces, Reserve, and Guard to provide greater access to course availability.

- Navy SEAL Lt. Michael P. Murphy Memorial Scholarship Award





Commission for Adult Learners Update from the Committee on Military and Veteran Services

This spring, a survey was sent to all active duty military, veterans, and members of the reserve/National Guard to discover gaps in support services and to gather information for future planning efforts. Highlights include:

87.2% agreed that "my campus is welcoming toward military and veteran students"
