## Commission for Adult Learners September 8, 2010, 10:30 a.m. Senate Room, The Penn Stater Conference Center Hotel Minutes-Draft

- 1) Keith Hillkirk called the meeting to order.
- 2) Introductions and Announcements
  - a) Members introduced themselves and Graduate Student member Armand Dotsey shared his experience as an undergraduate adult learner.
  - b) Beth Ann Delaney gave an overview of the Northeast Alliance. The role of the Alliance is to build strength among the University's Scranton, Hazelton, Schuylkill, Lehigh Valley and Wilkes-Barre campuses. Committees are forming in an effort to create a hybrid approach including opportunities via Polycom, online learning, and accelerated course offerings, to look at gaps and to clarify procedures.
  - c) Deb Straussfogel shared details of a rebate program as an opportunity to help students with finances. Link to information on the program is available at <u>http://www.ds.psu.edu/StudentServices/Rebate.htm</u>. Gary Lawler noted that the Hazelton campus dedicates campus monies to student programs as an investment in providing financial aid. Keith Hillkirk shared that the Schuylkill campus has a 'Thirty-Plus' program that provides funds to adult learners.

- d) Martha Jordan shared that Terrell Jones has provided an EOPC grant in sponsorship of the Commission, with designation that the funds be used to benefit women, minorities, military students, the LGBT community, and first-generation college students. The Incentive Grant proposals will ask campuses to focus funded initiatives on these groups of interest.
- e) The Faculty Survey will be done as a pilot at the Altoona, Schuylkill and Lehigh Valley Campuses. Then, if needed, revisions will be made before the survey goes University-wide.
- 3) Minutes from June 9, 2010, were approved by voice vote.
- 4) Ann Williams and Martha Jordan summarized Commission goals for 2010-11 based on the Plan to Implement the University Faculty Senate Advisory and Consultative Report, *Recommendations for Enhancing the Educational Experience of Adult Learners*, March 16, 2010. (Attached). The Commission is charged with working on the below recommendations:
  - Recommendation 3; Conduct a system-wide audit of the academic colleges and departments to identify those courses eligible for credit by examination (Senate Policy 42-50) and Credit by Portfolio (Senate Policy 42-97) and provide the information to all units that advise/counsel adult learners. The PLA Committee will work on this initiative.
  - Recommendation 4; Expand the network of faculty who work with eligible students through Credit by Examination and/or Credit by Portfolio. The Faculty Engagement Committee will work on this initiative.
  - Recommendation 7; Explore the expansion of already-existing financial aid services available to adult learners. The newly created Financial Aid Task Force will work on this initiative.

Progress reports are due to Dr. Craig Weidemann by October 3, 2010 and final reports are due to him by January 3, 2011.

Individuals working on these initiatives will be invited to share their findings at the Hendrick Best Practices for Adult Learners Conference on May 16, 2011.
