- **A. Welcome** Kelly welcomed everyone to our meeting. Yvonne will be joining us, but closer to 11:30am today.

B. Approval of Minutes

Yvonne joined at 11:30am, she indicated she appreciated our recordings as she cannot always attend. She appreciates the dedication the commission members give to CAL. She mentioned that in undergrad education much of the conversation focuses on traditional age students. Although it is an important part of our PS population, it is good this group focuses on the interests in adult learners. She mentioned we need to pay attention to where are the "pain points" for this group.

They discussed adult learners not having to get a HS transcript. They do not need to do this, so make sure our language is clear that it is fine. This could be a "pain point" for these students.

Yvonne asked that we continue to elevate these types of policies that can hinder the adult learner.

Jeff Adams is co-chairing a committee looking at the possibility of a new degree audit and planner tool. This planner tool could help the transfer students. We

need to look at very clear pathways to degree completion. Arizona state announced they were having direct pathways from all community colleges.

Sawroop reintroduced the AP limitations to under 21 years of age and if there is opportunity to review this with the College Board. Michelle mentioned that credit by exam could be another way to achieve prior credits.

Good discussion was had about serving adult learners and how it helps all populations when we discuss and solve issues for any special group.

D. Hendrick Award Process Update - We had selected the winner, and announcements are coming. Awards ceremony is upcoming. The winner will be joining us next year in the Commission.
