Opening Remarks- Jeff Warner

Welcome from Jeff.

Opened Floor for any questions/comments/concerns- no one asked any questions Provided quick overview of committees, roles of chair/co-chair in the committee

- Adult Learner Data Updates- Whitney Zimmerman- data liaison
- Undergraduate level information only
- Review of Adult Learner Definition
- Reporting done annually
- Adult Learner Dashboard is available on <u>Sharepoint</u> (Search Adult Learner Dashboard)
- 4 Academic Years shown during presentation
- Biggest decline between 2020-2021
- Decrease in adult learners is higher than decrease in overall traditional age students.
- CC steady decline ( both adult and traditional students are down)
- UP remains constant (headcount remains steady for adults and traditional)
- WC also has seen a decrease over 4 years. (trends are inconsistent due to pandemic- temporary change of campus students due to change of campus)
- Whitmey can provide additional data if anyone needs it.

- Libby asked if CAL is inclusive of Graduate Students since this information is focused on UG only. Eugune McFeely offered that he did include GR students in his focus groups.
- Jeff Warney echoed that GR students are a consideration since most GR students are adults. We don't have VP of Grad included in the CAL. Should the sponsors reach out to see if GR would like to be included.
- Nontraditional students should also be included.
- Clayton asked that we keep UG and GR data separate since the populations of these groups are very different. (EX; GR students have already demonstrated success)
- Jeff asked if Whitney can pull GR data- Whitney can provide all of WC data but not all campus data. Getting access to GR data may be tricky.



- Executive Board will bring this up to sponsors to see if we can get VP of Gr education involved in CAL.
- Melissa Kuhns stressed that we keep in mind how COVID impacted all data and numbers are skewed.
- Libby suggested that if we are going to focus on UG students we need to make that a clear statement. Jeff talked about non-traditional students and the definition of an adult learner
- Eugene included GR students since they have issues; Child Care, Finance, Life- Issues and Course Timing, Availability. Very similar to other students.
- We will try to get GR school support so we can have data we need.

Hendrick Conference

- Agreement to make it bigger, better and host every other year.
- Jeff spoke to Renata about this.
- Hendrick Family does not provide any monetary support-
- The Family is very supportive of making it bigger and a National Conference even if that means every other year.
- Goal for the committee is to start this process how to make it bigger.
- Look into if C&I can run operations of the conference.
- Sponsors said they will assist with cost associated with turning this over to C&I
- No Conference this year- SP24 would be the next conference.
- John- asked if there were any funding restrictions (Jeff said he is not aware of any restrictions-IN the past we had money for keynote speakers)
- JoAnne- Focus on making it bigger and more National- how do we want to promote this to increase attendance is some funding earmarked for promotion? Charles echoed that you cannot have volunteers with full-time jobs marketing this. C&I should include nationwide marketing plan. We have a year and a half to get this pulled together. We need to have a large audience to off-set costs. Does C&I have a marketing arm? Jeffrey W said that C&I does have a marketing arm and can share this information broadly and to the correct audiences.
- The Hendrick Award will still take place annually. They will be invited to the conference.

Jeff put all members into their break-out rooms for 20/25 minutes for discussion. Chair will be asked to provide summary after the breakouts. Going forward Chairs will be asked to provide updates at meetings. It is encouraged that committees will meet outside of meetings but we will always try to have time in the monthly meetings for committee meetings.
